Dave Ross was appointed by Governor Scott Walker to serve as Secretary of the Wisconsin Department of Transportation (WI DOT) beginning in January 2017. Wisconsin DOT is one of the largest state agencies, with about 3,500 employees and an annual budget of more than \$3.5 billion. The department supports all modes of transportation, including state highways, local roads, railroads, public transit systems, airports, and harbors. In addition, the department includes the Division of Motor Vehicles which serves about 50,000 customers each week, and the Division of State Patrol that enforces laws and assists motorists throughout the state.

Secretary Ross first joined Governor Walker's cabinet in January 2011 as Secretary of the Department of Safety and Professional Services. DSPS is responsible to help ensure the safe and competent practice of licensed professionals in Wisconsin, while enforcing laws that support safe and sanitary conditions in public and private buildings.

We were honored to be able to present him with an award for all his help with the campground code, the building code and several other issues he worked on side by side with WACO. # **Legal Question of the month**

#### How long do you keep applications?

I recommend retaining all employee records for at least 12 years, because that's the longest statute of limitations in the employment context. This is another reason why I recommend that all businesses convert to paperless document management. I would like to do a seminar on that topic. It is cheaper than paper documents and files -- by a large margin. Less storage space, ability to find everything instantly and low initial costs to convert. Plus, there's no need to destroy old records; they stay on a hard drive or a server.

## **Sales Tax Question**

#### I'm buying a golf cart to rent - do I pay sales tax on the cart now?

If the campground's **only** use of the golf cart is to rent to others for a fee, then the campground may purchase the golf cart without tax, for resale. However, if the campground uses the golf cart for any other purpose (e.g., campground or employees use the golf cart, golf cart is provided complimentary with the rental of a cabin), the campground's purchase of the golf cart is taxable.

# **ARVC's Truffle Contest!**
