Hershey, Pennsylvania CAMP



Dark Stores Study Committee Takes Shape

The Wisconsin Legislature's Joint Legislative Council voted on April 13th to form a Legislative Study Committee on Property Tax Assessment Practices, a/k/a "dark stores." The scope of the committee is to "review current property tax assessment practices, including the review of statutory, administrative, and judicial directives on assessment practices and the consistency of assessment practices throughout the state." The Committee will be chaired by Senator Luther Olsen, who is a co-author of both dark stores bills, and the vice chair is Representative Scott Allen, who is a co-author of one of the bills. WMC is working with a coalition of taxpayers to push for equal representation for taxpayers on the committee. The committee makeup should be known in the next few weeks.

U.S. House GOP Pushes to Make Individual Tax Cuts Permanent

The U.S. House of Representatives is planning to vote on legislation making the individual tax cuts in the Tax Cuts and Jobs Act (TCJA) of 2017 permanent. U.S. Rep. Rodney Davis (R-III.) introduced legislation to extend the tax cuts. While the legislation had originally been scheduled to receive a vote on or around Tax Day (April 17), the vote was pushed back after some members of the Republican House Caucus expressed concerns about increasing the national debt.

Recently the Congressional Budget Office projected the national debt will equal the United States' entire economic output by 2028. Making the TCJA individual tax cuts permanent could add between \$573 - \$736 billion to the debt. Representative Davis suggested a vote could take place later this spring or

Congress Makes Progress on Bipartisan Bills Reforming IRS

Earlier this month the U.S. House of Representatives passed a package of bipartisan reforms looking to improve the IRS's taxpayer services, appeals, and cyber security functions. The 21st Century IRS Bill (HR 5445) was approved 414-to-0. In addition, the Taxpayer First Bill (HR 5444) passed by a 414-to-3 vote.

Changes included:

Continue the "free file" program allowing low-income taxpayers to receive free tax preparation software. Make the Volunteer Income Tax Assistance program permanent allowing the IRS to collaborate with nonprofits to help low-income people and those who speak limited English file their taxes. Encourages the IRS to develop and maintain public-private partnerships to prevent identity theft. Requires the IRS to create a program to issue identity-protection personal identification numbers to any taxpayer who requests one and create a single contact point for identity theft within the agency. The package also creates an independent appeals office to enhance taxpayer rights during the IRS ³ enforcement process.

Small Businesses Drive Job Growth in Wisconsin Account for 35,895 Net New Jobs, Latest Data Shows

WASHINGTON, D.C. – The Office of Advocacy, an independent office within the U.S. Small Business Administration, today released its annual Small Business Profiles. The user-friendly profiles utilize the most recent statistics on employment, industry, and economic growth from federal data sources to create a small business narrative unique to each state.

Wisconsin's 2018 Small Business Profile shows that small businesses added 35,895 net new jobs during the latest year studied. There are 448,032 small businesses in Wisconsin, which employ 49.7 percent of the state's private workforce. The top three industries for small business employment in Wisconsin are (1) manufacturing, (2) health care and social assistance, and (3) accommodation and food services.

"Small businesses are Wisconsin's economic engine," said Acting Chief Counsel Major L. Clark, III, "they are the key to the state's ability to grow economic output, entrepreneurship, and private sector employment."

Among other findings, the 2018 State Profile reveals that in the third quarter of 2017, Wisconsin grew at an annual rate of 3.2 percent. In January 2018, the unemployment rate was 3.1 percent, down from 3.5 percent in January 2017.

"The Small Business Profiles are a valuable resource for researchers, stakeholders, and small entities who are interested in small businesses' contributions to the U.S. and state economies," continued Clark.

The profiles are based on data from the U.S. Census Bureau, the U.S. Department of Labor, and other federal agencies. They include the 50 states, the District of Columbia, the United States, and the U.S. territories.

I have been fielding questions and concerns from park owners regarding the Great RV Escapes program http://greatrvescapes.com/ which is a marketing company and not associated with arvc or Go Camping America.

Owners have had guests refer to the parks listing on the website and the owner was not aware they were listed there. Great RV Escapes clearly has a disclaimer that says: This Free RV Park Directory is for your trip planning enjoyment only. It is to be used for Reference Only as parks listed here may or may not be included in the Subscriber Only Directory. They sell RVers a subscription for discounts similar to Passport America.

The confusion arises when the guest requests the 50% discount and the park was unaware of the program and hadn't signed up for it.

I randomly selected arvc member parks that were listed and called them to determine the parks awareness of their listing and the Great RV Escapes program.

•One park had signed up for the program.

•One park was familiar with it and had requested to be removed from the listing but that hadn't happened yet.

•All others had no clue they were listed.

I made a call to the Better Business Bureau to explore what options were available for owners who did not want to be listed on this website. The BBB said these issues are best resolved between the two parties and the first course of action by the owner should be to request the company to remove their listing. I called Great RV Escapes and spoke with Resort Operations Director, Drew Durrer. I inquired about the criteria they use for listing parks on their website and he said it is usually through personal solicitation from them or the park contacting them directly.

I told Drew that one of my members listed on his website was not open to the public and did not desire to be listed. He said if any park wanted removed or added they could contact him at: Drew Durrer

ROOM TAX QUESTION & ANSWER

If the charge is only for a campsite (no cabin or RV provided), then the charge is not subject to the local room tax. It is the sale of a taxable admission service.

If the charge is for a campsite with a cabin or RV on it, then the charge is subject to the local room tax. It is the sale of a taxable lodging service.

Seasonal RV campsite rentals are required to pay sales tax.

ARVC TRUFFLE CONTEST

NOTICE CONCERNING SERVICE AND COMFORT ANIMALS

SERVICE ANIMALS

We welcome service animals assisting persons with disabilities. Service animals are limited to animals individually trained to do work or perform tasks for the disabled. Service animals must be harnessed, leased or tethered. We may ask whether the dog is a service dog required by a disability, and, what work or task the dog has been trained to perform. Service animals are allowed in any premises where guests are welcome, but must be under the immediate control of the owner at all times.

COMFORT ANIMALS

We do not allow guests to bring animals, including dogs, as emotional support or comfort animals. The Americans with Disabilities Act does not require business to allow support or comfort animals. This is true even if the support or comfort animals are "registered," wear a vest or have a doctor's note.¹

Building Commission Approves Projects

MADISON – The State of Wisconsin Building Commission, chaired by Governor Scott Walker, met today to approve several key projects across the state including:

- Structured cabling upgrades and other renovations and improvements to buildings at the Southern Wisconsin Center.
- Various remodeling and electrical system safety improvements at the Wisconsin Resource Center.
- Parking, site fencing and other repairs and remodeling at a variety of Department of Military Affairs locations.
- Authority to construct new indoor fish hatchery facilities at the Kettle Moraine Springs Fish Hatchery, expanding capacity meet the stocking needs for Lake Michigan fisheries.
- Addition to the Department of Natural Resources' (DNR) existing Hayward fire control storage building in Sawyer County.
- Authority to expand electrical service to as many as 200 state park campsites to meet customer needs, and to
 perform other work at select sites.
- Authority to plan for the new UW-Platteville Sesquicentennial Hall project.
- Renovations to McMillan Hall restrooms at UW-River Falls.
- Other various maintenance and repair projects around the state.


