124 campgrounds attended, our sponsorships \$37,500, in-kind sponsorships \$32,500 a total of \$70,000 in sponsorship

Course Evaluations: came in at 4.75!

Vendor Evaluations: A few rated us poor communication. But we sent out over 174 communications to vendors.

Value of the Players: \$7,770 in Devante Adams autograph cards

Health Insurance Update: Still working on it, Best option will be the Restaurant Association. They have all our information. We don't have to be a member of them but they have to have us in their data base.
