# HELPFUL LINKS FROM THE TLW RELATING TO THE COVID-19 PANDEMIC

The economic disruption caused by the COVID-19 pandemic is hurting not only tavern owners across the state, but also our many dedicated employees that are essential to our operations. TLW is committed to helping our members, and their employees, during this difficult time find the resources they need to survive the business interruption so they can resume their operations once our communities have recovered. Below you will find various links to help you know how you can remain open, what types of assistance are available to you as a business owner and your employees, as well as what things the TLW is doing to assist you during this difficult time.

## MARCH 24TH EMERGENCY ORDER #12 - "SAFER AT HOME"

Governor Evers has issued a new Executive Order requiring all non-essential businesses to close. The order takes effect 8.00 am March 25th through April 24th or until the Governor lifts the order.

The new order allows taverns and restaurants to continue to offer food to be delivered or picked up. The new order also allows a tavern without a food license to sell liquor to go in the original unopened package. It is not legal to sell individual drinks to go like an old fashioned or margarita.

Below is the language taken directly from the Governor's order:

1. Carryout sales of alcohol beverages and food are allowed, if permitted by state law and municipal ordinance.

2. Delivery of alcohol beverages to retail customers is prohibited.

3. Wineries holding direct wine shippers' permits may make deliveries of wine in accordance with their permit.

4. Customers may enter the above establishments only for the purpose of ordering, pick up, and paying for food or beverage or both.

5. No seating may be provided.

6. Food and drink may not be consumed on premises, either indoors or outdoors.

7. Establishments shall meet Social Distancing Requirements between all individuals on the premises to the extent possible.

8. Self-service operations of salad bars, beverage stations, and buffets are prohibited.

9. Customers are prohibited from self-dispensing any unpackaged food or beverage.

# **TLW IS WORKING FOR YOU!**

Since the beginning of the COVID-19 pandemic, the Tavern League of Wisconsin has been in constant contact with the Administration, Legislative Leaders and other stakeholders to provide regulatory, legislative and commercial relief for TLW members.

Here is a list of items we are currently working on, and will communicate more information with you shortly.

 $\cdot\,$  Waive 2020 liquor/beer license fee and all other municipal and state fees for all alcohol/food license holders.

· Initiate a sales tax holiday for all sales at licensed establishments.

- Suspend 15 and 30 credit day law.
- · Permit sales of alcohol via phone/online transactions.
- Delay July 2019 local property tax payment for all license holders.
- Provide state credit for 2020 property taxes for license holders.
- · Create a state grant program for the hospitality industry employees and owners.
- · Provide mortgage/rent relief to delay monthly payments without penalty.
- Business insurance coverage.
- $\cdot\,$  Working with beer/liquor wholesalers regarding inventory buy back as permitted by the federal Alcohol and Tobacco Tax and Trade Bureau.
- Working with Cable/Satellite Companies to suspend service fees.

# WISCONSIN DOR ALCOHOL BEVERAGE GUIDELINES & INFORMATION RELATED TO COVID-19

The Wisconsin Department of Revenue has issued a proposed guidance document to provide clarification regarding the permissible production, distribution, and sales of alcohol.

#### SMALL BUSINESS ASSISTANCE

The Wisconsin Economic Development Corporation is providing up to \$5 million in grants to help small businesses in Wisconsin offset loses related to COVID-19 response measures. Grants may not exceed \$20,000, and are for companies that have 20 or fewer employees. Other restrictions may apply.

In addition, Governor Evers is requesting loan assistance from the US Small Business Association. The SBA's Economic Injury Disaster Loan program provides up to \$2 million in financial assistance to recipients, usually through long-term loans with low interest levels.

The Wisconsin Department of Revenue has <u>announced</u> that they are extending the deadline to file state income taxes until July 15<sup>th</sup>, similar to what the IRS announced previously.

Stay tuned for additional resources. Both the Federal and State Governments are currently working at providing economic relief packages.

**Unemployment Compensation** 

A note to those looking for financial assistance during these difficult times. If your employer must shut down operations and no work is available, you may be eligible for unemployment benefits if you meet certain criteria. In addition, individuals who have tested positive for COVID-19, are showing symptoms for COVID-19, or has been quarantined by a medical professional may be available for temporary assistance.
