- 6. President's Report Scott Kollock
 - Nominations for Board
 - Tiffany Pargman 2nd term, accepted
 - Julie Michaels 2nd term, accepted
 - Joe Ledger of Lakeside Fire Campground & Waterpark is sending in his bio/image and is interested in running for the open position.
 - Bud mentioned an interest if there were no other people running.
 Group acknowledged he is currently in the Past President role, so if Joe wants to step up, we should move forward with that nomination.
 - 2025 Budget listed in Committees, discussed as a group: LY listed and actual here to review for the group.
 - Interest \$9K in last year when usually nothing, additional interest in checking and savings;
 - Madison Show Booth work out a deal with Don and having that special area out front – was \$9K, now down to \$6K
 - ARVC/OHI dues no longer a line item as we are no longer collecting those dues;
 - Changes for Convention both on income and expense side;
 - Legislative Expense substantially to cover a lobbyist should we opt to move forward.

- Travel/Other increased slightly to continue to support travel to additional shows, RVIA, etc.
- Made money and we're well in comparison to any others keeping things even and have a balance budget presented here.
 - Question: Any IRS restrictions on what we can have set aside? Scott –
 we've reviewed that in the past and if we include our whole budget,
 we've got 1-year set aside and we're just fine that way. Never gotten
 any questions so far.
 - Question: Jim what was the total spent with Mark for Washburn? \$5K was the total we agreed upon and the line item listed reflects the grand total.
 - Discussion: Tina brought up Kids Kamp and how if the bus doesn't get covered annually, we'll have to adjust for that.
 - Discussion: Legislative line item could be increased from Legal or subscriptions if we end up going with another lobbyist as the quotes we're getting in are higher than the line item.
 - Narrowed down the budget to general line items vs. itemization for everything avoiding a 6 page budget. Always have additional backing of information should it be requested.
 - Rob moved to accept 2025 budget, Tiffany 2nd, all in favor, none opposed, BUDGET PASSED.
- Well Grant from DNR supporting replacement, structures and abandonment of private wells. Award up to \$16K with cost share of \$0. Levels for nitrates have been lowered, now lowered down to 10 vs. the 40 previously noted. Other requirements as well. Details in the DNR. Based on the owners income for grant assistance, so that may negate eligibility depending on how you set yourself up.
 - ACTION ITEM: SEND OUT DNR well information to group and in newsletter.

7. OHI Update - Jim Button

- OHI went to the hill, East Coast mini-conference for those that can't do the big conference day and half at Cherry Hill Park in Maryland anyone that wants to attend, we encourage it. Scott is the plan to do more of these throughout the country? Jim yes this is an initial trial, East Coast with amount of campgrounds, felt it would be a good fit for the region. Depending on how things go, they will plan additional. Lori will it be educational and trade show? Jim, more educational focused not everyone can go to the state or national shows, just a cost affordable option; time is valuable in the Spring and tried to work around the conventions of other groups to make this timeframe work.
- Spectrum if for some reason you have Spectrum, OHI signed on with AT&T for WiFi needs if you need that.
- Music License follow up from last meeting can an individual come on after deadline?
 Yes, they can, just have to pay regular rate, no discount.

8. Mark Hazelbaker, legal update

- Hotline questions prompt an article for next month what happens when a
 camper/seasonal guest passes away; will address it need to work with the estate,
 which is not always easy to do.
 - Jim: will you make this something easy for all owners to understand? Mark: under our current model agreement it clearly states only people on the agreement can lodge there; so unit can no longer be used onsite for the season the estate can keep paying or remove the unit from the property. Problem is, there is so many instances where there is no estate or set up based on the law.
 - Mike: Can we at least pull the unit off the site and reuse it for a new seasonal?
 Mark: Our current seasonal agreement already says that. I will present an article on this in the March newsletter.
- Legislative updates listed below in that section with Mark's comments indicated.
- Property Tax—We initially felt PPT was repealed and we were in a better situation, but instead, things are moving from PPT to real; some are being reflected in incredibly high assessments, others are being passed on to campground with no direction as to what we would bill back to each site. Over 2000+ townships issue will not go away and its difficult to tackle the situation. Was expecting there would be a trailer bill following up on ACT 12 legislation has been fighting over this for more than 100 years. We were offered assistance with DOR if we want to pursue any changes here with how the terms were written—we can offer comments.
 - Christina is there anything in legislation stating they have to use the same provider/assessor; Mark Utility does have set up but there is no way the township will do that. WPAM terms were set up to help provide direction but its causing more problems. Mark's recommendations: pick a few jurisdictions to litigate this issue and he is willing to step up and be that attorney. Values are out of whack.
 - Jim the amount of work an appraisal company does in the campground costs them more than what they get out of the campgrounds – if you talk to the campground is a big chore and would just as soon like to wash their hands with them as well.
 - Mark: concern re: per campsite fee or another fee Wheel Tax or Lot Fee –
 who knows what they'll come up to offset these taxes.

 - b. Phil officially put in notice yesterday with First-Mid but then registered his new bank. Lake Ridge is the new bank he's with now Janesville, WI.
 - c. Trade members are up
- Speaker/Program Update see new draft in your packets!
- Meals from the Board steak dinner; hotel breakfast will be donated by Jim B and their team – may look at the hotel vendor to assist with a "donation" for the meal. Tiffany has eggs to assist with.
- PAC Bob/Melanie offered to come and do the PAC Auction one last time this
 year, did discuss a mentorship and Bob is willing to do that, as well potentially
 deliver donations as his schedule allows. Connected with Ben and Mark
 Stefan will work Bob and see if this is something they can take on in the
 future.
- o Awards Update Bob Weiss (Volunteer of the Year) & O'Neil Creek HOF
- Scott Grenon Memorial is there anything we want to do here? Julie let me know they have the park listed and its not confidential. They will do their best to get through this season and want to make a move.
 - Jim: Will reach out and ask Julie what would make sense for a memorial.
- Passport example in your packet
- Basket Raffles challenge each other on baskets you've got or auction items you're doing.

- Print Program Update all invoices have been sent with shipping included; if you have remaining print program items, please schedule a pick up time to ensure we have your items ready and staff at the office!
- Website/FB/Instagram Update January updates in your folders.
- GBF Updates \$254,294 starting off 2025 strong with a \$2400 donation. There will be several less events in 2025 with GBF, so you need to let Carla know ASAP. There will be a new license in March/convention or else immediately after in April. There will be a more structured process with who has is and the donation coming back to the office. Not planning on having a player there but will see about the rates at this time.

• RV Shows

- La Crosse: Fri afternoon & Sat very busy, Sun steady; Thurs was VERY slow; distributed all allotted directories and (1) additional box!
- Central RV Show Wausau: This RV show was not good. The weather ruined it with 10 inches of snow over Friday night into all day Saturday. We gave away maybe 700 bags; 10 booths were empty from vendors that did not show. We had 4 WACO Campgrounds there. Cancelled RV show they do every other year in march and tried to merge it wasn't a good move.
- Christina Rosemount in Chicago was lower b/c of the weather, but Madison was great for ELS. Think if people missed other shows because of weather – Milwaukee, GB & Madison.
- Other updates from the group; Madison was down about 400 people/day and he attributed it to the same 2 shows at the same time and neither of them will move show. Madison is the most cost effective, GB is the most costly.
 Milwaukee – more expensive but higher distribution.
- Hoping the promotions with Dicks and Scheels will help us distribute better will include WACO in their program helping with GBF and the promotion.

• Legislative Updates

- Criminal Trespass at a Campground and Providing a Penalty-LRB-1166-P2 we asked for a couple of changes on this due to the verbiage being stronger than the current enforced WI state language regarding trespassing Mark came up with some changes and sent those back to Andre's office and am waiting on Mark's review to say its good to go. This is our first step in getting better assistance with abandoned RVs. Mark Comments: I would make it very clear that seasonals are not tenants, and we're not landlords & I will push them to legally assist with removal.
 - Jim: Is this something similar with the self-storage legislation and abandoned mfg homes? Mark: if we could fit this into the bill, I'd strongly request the board do that as well. Christina: What if unit is not worth any value it just needs to be disposed of, how do use the self-storage law? Mark you'd put property up for disposal (Sec. 704.90 of wis statute); clearly states self-storage has a lien on all property stored –

- if person abandoned, you can recycle/sell/landfill or dispose in another manner that's reasonable. If legal notice is given, you can sell and pay the lien back. Worthless campers would still require this process but you can still get it taken care of.
- To clarify this legislation will help us make it more clear that we aren't landlords, guests aren't tenants and we can lean on self-storage rules already in place if we get this legislation passed.
- LRB-0444-P2_AmusementRides this one is approved to send, but I am a little worried about the backlash from DSPS. We have a newly appointed Deputy Dir Jennifer Garrett. She was the Assist. Dep. Dir last year, newly promoted and she was ready to fight us based on previous legislation we had proposed on this issue. Jason suggested we present the legislation to her and DATCP to allow for them to comment before we present back to Andre's office to get the ball rolling. Thoughts on providing both offices a preview?
 - Mike: do we need to say anything in here about insurance being covered/provided in the language on those that are exempt due to mfg installation?
 - Ben: Are we in any way asking to be "special?" Permanent installation?
 Yes, we're asking to be exempt from the current code.
 - Jim: Do we have committee for this? We need to know what might come next – unique toy from a vendor and then we find out its got to be registered and what not.
 - DSPS & DATCP review and then move forward with legislation.
- Property Tax met with Jason and Evan Umpir and they will both join us for legislative luncheon to discuss this issue further. Lori/Scott/Bud/Adam and Tina met with the DOR and they basically said they feel our frustrations and offered to connect us with contacts at the WAAO and also would create a 1-page document to assist with clarity to assessors. But, in the end, they take very little responsibility for the interpretations that assessors are putting in place. I've followed up since our meeting and got a short reply with no timeline in place. Meeting with Jason/Evan to discuss further thoughts on how to present solutions at our Convention in March. Andre's office is very willing to assist with language here, but we still haven't seen anything presented from Jim/OHI.
 - Indian Trails, Duck Creek & Plymouth all have an assessor that outlines
 everything with a spreadsheet; but most townships are not doing this or
 making things this easy.
 - Indian Trails falls into the Assessor case/review that Jim worked on.
 - Scott do you need to go back annually to the review to present information again at the review? Jim – doesn't believe so, but will find out and get back to the group. Scott – this carries through

- automatically? Jim I think so but will need to find out. So everyone with Associated Appraisers would be covered in this. Some board of reviews were already done; only had so much time to work with on this.
- Scott we're coming into this timeframe right now, so if another group wants to approach this, now may be the time to get something rolling with open book reviews.
- Jim told he'd have something in his hands by the end of this week, still don't have the legislative language.
- Jim will ask the question to see if there is an opportunity for those townships who didn't apply for the reimbursement for PPT to his tax attorney. Discussed how there was a deadline for that, but can do an application still to the DOR to get a prorated reimbursement for those losing funds due to less PPT.
- Scholarship Update Tia is here from YP to discuss their meeting and provide an update. Notes from their committee are also included in your packets! See notes from the scholarship commitment. (3) \$1000 scholarships were suggested and will have an application available for convention print and online version right now, summary of what should be included right now. Five young professionals on the committee and are open to others from the board joining.
 - ACTION ITEM: Include blurb about this in newsletter and be ready to present as new at Convention.
